






Remove components shown: Keep all components removed from machine.



- Install Passenger Lower Bracket (D) to stock location of Protection Tube. Secure with hardware shown.





- Tighten all hardware completely.
- Reinstall stock components; see pages 3 5.

- Install Passenger Door (A) to Passenger Upper Bracket (C) and Passenger Lower Bracket (D) with hardware shown.



- Install Passenger Strap (E) to Passenger Door (A) and Seat Frame with hardware shown.





- Close Door, engage Latch, and align to machine.


- Tighten all hardware completely.

- Repeat steps for opposite side.

- Remove hardware shown from Seat Frame.



- Install Driver Strap (J) to Driver Door (B) and Seat Frame with stock hardware.
